## Regular Board of Education Meeting ELCO High School Library

February 9, 2015

The Regular Board of Education Meeting was called to order by President Brandon Bernard at 6:04 p.m.

The Eastern Lebanon County School Board met in a Regular Session in the ELCO High School Library with President Bernard presiding and Mr. Jack Kahl leading the Opening Exercises.
