Regular Board of Education Meeting ELCO High School Library

The Regular Board of Education Meeting was called to order by President Boyer at 6:00 p.m.

 - IU₁₃ NO costs to the District for a full comprehensive search; only expenses incurred by the District would include advertising
 - Discussion took place and a recommendation to have the IU13 run the search was noted, with the entire Board viewing all applications received.
